## Scheme for Granting Permits/License to Import Fully Electric Vehicles by Sri Lankans Employed Abroad

As stated in the paragraph 6.2 of the Circular No. 02/2022 dated 31.08.2022, a letter of confirmation issued by the respective bank/banks stating the amount of foreign currency remitted to the country by the applicant during the period concerned and the amount of money out of such remittance converted into LKR should be furnished along with the application.
- 03. The attached Specimen of the Letter of Confirmation is to be used by the banks to issue the Letter of Confirmation in order to maintain the consistency of information and clarity.
- 04. Accordingly, you are kindly requested to circulate the Specimen of the Letter of Confirmation along with the relevant circulars through the Central Bank please.
- 05. Your cooperation in this regard is highly appreciated.
